Release Forms & Consent

Certification of Physical Fitness to Participate:

I understand that participating in any sport, including camp there is a risk of injury which could result in serious or permanent injury, paralysis, or death. To minimize the risk of injury, I agree to tell my child to obey all safety rules and to report fully any problems related to his/her physical condition to the camp coaches.

By signing below, I certify the following:

My child is not currently under any care of a physician for an injury or illness that would prevent his/her safe participation in the camp. My child has no history of fainting or any other problems related to strenuous exercise. I declare that my child is in good health and there is no reason he or she cannot safely participate in any strenuous physical activity.

By signing below, I hereby give permission for the camp director and staff to obtain medical treatment for my child in the event of accident or illness during his/her presence at the camp.

In consideration for accepting my child into camp, which uses university facilities, I hereby agree that I am and shall be responsible for all costs associated with any injury or loss that may be sustained by my child as a result of his or her participation at the camp. By my signature, I agree to release and promise not to sue Concordia College, Achiever Eleven Enterprises, LLC, or their employees or agents for any damages, loss, injury or death arising from my child's participation in camp, unless such damages, loss, injury or death are caused by gross negligence or intentional gross misconduct of such employees.

Photo Release/Agreement

I understand the College may take photographs of camp participants and activities. I agree that the College shall be the owner of and may use such photographs relating to the promotion of future camps and in any College Publication. I relinquish all rights that I may claim in relation to the use of said photographs.

ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY RELATING TO CORONAVIRUS/COVID-19

COVID-19 has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely dangerous and contagious. By signing this agreement, I acknowledge and agree as follows:

1. COVID-19 is contagious and dangerous.
2. Concordia College cannot guarantee that you, your child(ren), family members, relatives, and/or friends will not become infected with COVID-19.
3. Participating in any Concordia College camp activities may increase the risk to you, your child(ren), family members, relatives, and/or friends' risk of contracting COVID-19.

4. I voluntarily assume the risk that my child(ren) and I may be exposed to, or infected by, COVID-19 by participating in Concordia College camp activities and that such exposure or infection may result in personal injury, illness, permanent disability, and/or death.

5. I voluntarily assume the risk that any family members, friends, and/or relatives may be exposed to, or infected by COVID-19 by my child(ren)'s participation in Concordia College camp activities.

6. I understand that the risk of becoming exposed to, or infected by, COVID-19 while participating in Concordia College camp activities may result from the actions, omissions, or negligence of myself, my child(ren), and others, including, but not limited to, Concordia College, Concordia College employees, Concordia College volunteers, Concordia College coaches, families, other players and participants and their families.

7. I voluntarily and unconditionally agree to assume all of the foregoing risks, any and all risks associated with COVID-19, and any and all risks associated with participating in Concordia College camp activities, and accept sole responsibility for any injury or illness to my child(ren), myself, any family members, friends, and/or relatives (including, but limited to, personal injury, disability, and death), and any damage, loss, claim, liability, or expense, of any kind, that my child(ren), myself, any family members, friends, and/or relatives may experience or incur in connection with my child(ren)'s participation in any Concordia College camp activities.

8. On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless Concordia College, its employees, agents, representatives, coaches, volunteers, and representatives from and against any injury, personal injury, disability, death, illness, damage, loss, claim, liability, or expense, of any kind, including all liabilities, claims, demands, damages, actions, costs, or expenses of any kind arising out of or relating thereto.

9. I understand and agree that this waiver and assumption of the risk includes liabilities, claims, demands, damages, actions, costs, or expenses of any kind based on the actions, omissions, or negligence of Concordia College, its employees, volunteers, coaches, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Concordia College camp activity.
